#### 1. Amendment to Rule 24. SECURITY

Before a License is issued under these Rules, an amount calculated at a rate of Rs. 100 (Rupees one hundred) only for each of the Workmen to be employed as Contract Labour, in respect of which the application for license has been made, shall be deposited by the Principal employer / Contractor for due performance of the conditions of the license and compliance with the provisions of the Act and the Rules made thereunder.

Provided that where the principal employer / Contractor is a Co-Operative Society, the amount deposited as Security shall be at a rate of Rs. 20(Rupees twenty)only for each of the workmen to be employed as Contract Labour...
